

Terms & Conditions for giveaway of A Freeletics Valentine's

1. Promoter This promotional competition is run by Freeletics GmbH, Lothstraße 5, 80335 Munich, in the following "Freeletics".

2. Conditions of participation

To enter the competition the entrants must have a public in-app profile or a public Instagram profile, depending on the channel they enter with. In addition, entrants must be involved in the challenge procedure as mentioned below under § 4. By entering all entrants agree to be bound by these terms and conditions and any associated entry requirements.

It is a prerequisite for participation to have an existing user account at Freeletics. If the entrant does not yet have a user account for the Freeletics services, the entrant can open one. Only natural people of full age are eligible to participate. The employees of Freeletics GmbH and its affiliated companies as well as their relatives and all other parties involved in the execution of the competition are excluded from participating in this competition.

Automatically generated entries (e.g. via lottery service providers etc.) are void. In any case of a breach of these terms and conditions or the influence on equal opportunities, e.g. by technical manipulation, or a similar serious violation, Freeletics may, at its own discretion, terminate the participation of the entrant or change the terms and conditions of the competition. If a non-eligible participant is determined to be a winner, he/she will be denied the prize the Promoter reserves the right to re-draw another winner from the valid/correct entries that were received before the Closing Date.

3. Prize

The Prize is one of the following

4. Procedure

App Feed or on their Instagram Feed. The respective channel must be public. The winners will be selected among all participants in both channels.

Only personally, completely and correctly filled registrations participate in the competition. Competition closes at 11:59 pm MET on February, 15th 2020. Entries received after the closing date will not be counted.

The prize is non-transferable and non-refundable. No cash alternative is available in whole or in part.

The winners will be selected at random from all valid entries for this competition received before the Closing Date.

The winners will be notified on Tuesday, February 18th 2020. If the winner is selected from the Instagram posts, the winner will be notified via direct message. They will need to share their email privately in order to receive the prize. If the winner is selected from the Freeletics Training App Feed, the winner will be contacted via the Freeletics Email-address.

All reasonable endeavours will be made to contact the winner during the specified time. If a winner cannot be contacted or is not available, the Promoter reserves the right to re-draw another winner from the valid/correct entries that were received before the Closing Date.

The winner will be contacted via the given email address asked to send their address to receive the prize.

5. Warranties and publications

The participant declares by participating in the competition that the respective e-mail address is his own and is not owned by a third party. Should third parties file any claim against the promoter for infringement of their rights in connection with the respective e-mail address, the participant bears full responsibility for the damage suffered by the third party.

6. Data Security - Declaration of consent

As far as personal data from participants are collected in the course of the competition, these are collected, processed and used by the promoter solely for the purpose of carrying out and processing the competition. The data will be deleted within 30 days after the competition has been carried out. The participant may object or withdraw his consent at
