

Terms & Conditions for competition Defeat the Monsters

1. Promoter

This promotional competition is run by Freeletics GmbH, Lothstraße 5, 80335 Munich, in the following, "Freeletics".

2. Conditions of participation

To enter the competition the entrants must use the Freeletics Bodyweight App and have a public profile in the app. They must complete at least one of the five required workouts (Arachne, Kyklops, Medusa, Minotauros, Typhon) for the particular time frame (October, 28th until October, 31st 2018) and post this to the Freeletics Bodyweight App feed with an original photo of them with a Halloween theme. By entering, all entrants agree to be bound by these terms and conditions and any associated entry requirements.

It is a prerequisite for participation to have an existing user account at Freeletics, a Freeletics Training Coach subscription and a public profile within the application. If the entrant does not yet have a user account for the Freeletics services, the entrant can open one. Only natural people of full age are eligible to participate. The employees of Freeletics GmbH and its affiliated companies as well as their relatives and all other parties involved in the execution of the competition are excluded from participating in this competition.

Automatically generated entries (e.g. via lottery service providers etc.) are void. In any case of a breach of these terms and conditions or the influence on equal opportunities, e.g. by technical manipulation, or a similar serious violation, Freeletics may, at its own discretion, terminate the participation of the entrant or change the terms and conditions of the competition. The participation in this promotion is free of costs.

If a non-eligible participant is determined to be a winner, he/she will be denied the prize the Promoter reserves the right to re-select another winner from the valid/correct entries that were received before the Closing Date.

3. Prize

<u>1 top prize:</u> 50 euros Wear Voucher to use in our <u>online Wear Shop</u> **or** a Free Training Coach for 6 months if the user lives outside the European Union, the United States, Switzerland and Norway.

<u>5 additional prizes:</u> 20€ Wear Voucher to use in our <u>online Wear Shop</u> **or** a Free Training Coach for 1 month if the users live outside the European Union, the United States, Switzerland and Norway.



4. Procedure

The competition takes place in the period October, 28th - October, 31st 2018. Participants enter the competition by completing at least one of the 5 workouts during the given time frame and posting this in the Bodyweight app feed with a photo that they have taken with a Halloween theme.

Only personally, completely and correctly filled registrations participate in the competition. Competition closes at 23:59 on October, 31st. Entries received after the closing date (depending on your time zone) will not be counted.

The prize is non-transferable and non-refundable. No cash alternative is available in whole or in part.

The winners will be selected according to the best photos from all valid entries for this competition received before the Closing Date. The participant must have an existing user account with Freeletics GmbH during the entire competition period.

Winners will be notified by email, confirming the entry of the competition as well as the winning (including the prize as a voucher code) within 5 days after the Closing Date. All reasonable endeavours will be made to contact the winner. If a winner cannot be contacted or is not available, the Promoter reserves the right to re-reselect another winner from the valid/correct entries that were received before the Closing Date.

5. Warranties and publications

The participant declares by participating in the competition that the respective e-mail address is his own and is not owned by a third party. Should third parties file any claim against the promoter for infringement of their rights in connection with the respective e-mail address, the participant bears full responsibility for the damage suffered by the third party.
